I hereby release Cornerstone Trinity Baptist Church ("CTBC"), its officers, directors, employees, members, volunteers, and agents (collectively, "CTBC Released Parties") of and from any and all actions, suits, proceedings, claims, demands, assessments, judgments, damages, deficiencies, liens, penalties, fines, costs and expenses, including reasonable attorneys' fees, resulting from, based upon, or arising out of any activity, accident or injury that occurs at the Summer Basketball Camp or en route to or from the Summer Basketball Camp.

I accept and assume all risks and injuries that may result from the Summer Basketball Camp, even if it arises out of negligence or carelessness on the part of the CTBC Released Parties

I agree that any lawsuit that is brought against any of the CTBC Released Parties relating to this Agreement shall be brought only in California. This Agreement shall be construed under and governed by the laws of the State of California, without reference to the conflict of laws rules. If any portion of this Agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.
